Week 1 of the 81st Legislature

The 81st Legislature is off to a quick start. Through today (January 19th) some 352 bills have been introduced in the House and Senate. Additionally, several resolutions have been drafted.

Two bills have been introduced so far dealing with "prevailing wage." **SB 100, introduced by Senators Carmichael, Blair, and Mullins** would require that the Commissioner of Labor base the determination of prevailing rates on statistics made available by the United States Department of Labor, Bureau of Labor Statistics. The bill would further provide a county commission with the authority to review the determination. **SB 245, introduced by Senators Trump, Blair, and Walters** would simply repeal requirements to pay prevailing wages for construction of public improvements.

Two resolutions have been introduced to increase the homestead exemption. **SJR 3 introduced by Senators Snyder and Miller** would provide an alternative method of calculating the homestead exemption based on the average cost or value of the residential property by county. The exemption may never be less than \$20,000. **HJR 3 introduced by Delegate Lane** would increase the homestead exemption from \$20,000 to \$30,000. However, if the homeowner's federal adjusted gross income is equal to or less than two hundred percent of the federal poverty level the exemption shall be the greater of \$30,000 or fifty percent of the average sale price of homes in that county during the five preceding years, provided that the exemption may not be greater than fifty percent of the average sale price of homes in the state during those five preceding years.

A 3rd resolution was introduced (**HJR 1**) by **Delegates Anderson, E. Nelson, and Gearheart** to permit the Legislature to exempt from ad valorem taxation tangible

personal property directly used in commercial and industrial businesses, or such components thereof as the Legislature may in its discretion designate. There is nothing in this resolution to replace lost revenue to county government.

I will attend a meeting with the Governor's Office tomorrow on the issue of the **Statewide Interoperable Radio Network (SIRN)**. Currently by executive order of the Governor, the governance of this network is administered by the WV Statewide Interoperable Executive Committee (SIEC) a cross-functional body that is comprised of representatives from several state and local agencies, including the County Commissioners' Association WV, WV Enhanced 911 Council and the WV Sheriffs' Association. The radio network must also be maintained. It is quite expensive to do so and there is no longer any federal grant money for this purpose. Recently there have been discussions about moving the governance and maintenance of the system to DMAPS under the State Police and using a portion of the wireless phone fees to fund the work. The WV Enhanced 911 Council is opposed to this proposal and CCAWV is opposed to reducing the wireless 911 fees that fund county 911 operations! I will keep all posted as things develop.

House and Senate Amend Rules to Allow for Economic Impact Studies

The House and Senate amended their rules this week adding a provision that allows the Senate President and House Speaker to require **Economic Impact Studies** on certain bills. These studies would look at whether the bill is good or bad for the economy and would determine how many jobs and the amount of wages a bill would create.

SB 258 titled "Creating Letting Our Counties Act Locally Act" was introduced this week by Senators Beech, Williams, Prezioso and Kessler. The bill would give each county commission authority to submit road and bridge construction projects to the Commissioner of Highways. It would authorize county commissions to impose a **county transportation sales and service tax and a county use tax**, at a rate not to exceed one percent, to finance the construction, in whole or in part, thereby accelerating the time for completion of those projects. The bill states that the taxes would be collected by the Tax Commissioner, at same time and in the same manner as the state consumers sales and service tax and use taxes are collected. The bill permits the net county transportation sales and use taxes would be deposited in the County Road Improvement Account, a new account that would be created in the State Road Fund, to the credit of the county's subaccount in that account. It states that the funds in the subaccounts could be used to fund road and bridge construction projects on a cash basis and the Division of Highways would be authorized to issue special revenue bonds to finance construction secured by the county's subaccount.

HB 2011 introduced this week by Delegates Howell, Rowan, Moffatt, Hamrick, Householder, J. Nelson, Statler, Walters, Arvon, Kessinger and A. Evans would require Assessors to value certain wireless businesses' property ("antennas") as **mandated salvage value (5%)**. In this bill "Antenna" means a

tower used for the purposes of transmitting cellular or wireless signals for communications purposes, including telephonically, or for computing purposes; (1) In a county of less than twenty thousand in population; and (2) Within four miles of a four-lane highway which is either completed, under construction or designed and planned to be constructed.

HB 2137 introduced by Delegate R. Phillips, H. White, Walters, Eldridge, Marcum, Smith, R., Reynolds, Storch, Moffatt, Sponaugle and Ashley would provide to counties an hourly cost when paying for the incarceration of inmates in **regional jails** instead of a daily rate.

HB 2199 introduced by Delegates Hamilton, Ferro, Lynch, Phillips, L., Guthrie, Longstreth, Evans, A., Wagner, Statler, Kurcaba and Romine would **increase the fire and casualty insurance surcharge** from .55% to 1% The bill provides that the collected funds be distributed **solely to volunteer and part-volunteer fire departments**.

Two more resolutions (**HJR 4, HJR 5**), have been introduced to increase Homestead Exemption and one more (**HJR 7**) to eliminate the personal property tax on manufacturing inventory. **HJR 8** is a resolution to amend the State Constitution to give the people the powers of initiative, referendum and recall. The resolution sets forth its scope, limitations and exceptions.
