## CCAWV Hosts 2019 Legislative Conference



CCAWV hosted its Annual Legislative Conference, January 13-15 at Embassy Suites in Charleston. Speakers included Senate President Mitch Carmichael, Senators Joe Manchin and Shelly Moore Capito, Congresswoman Carol Miller, Governor Jim Justice, Commerce Secretary Ed Gaunch and other representative from local, state and federal government.

Presentations were also made by General Hoyer regarding the RISE program and updates on flood relief; the continuing opioid lawsuit updates from Paul Ferrell with

Green Ketchum Bailey and Tweel; updates on proposed 911 legislation from Dean Meadows of Wyoming County and an overview of a pilot program at Western Regional Jail from

representatives of DMAPS. The focus of this conference to discuss issues that may affect counties and possible solutions to those issues. CCAWV focuses on communication of the Legislative Platform and Legislative Priorities, which were established at the Fall Board Meeting September. With several new county commissioners elected this past November, this conference provided a number of networking opportunities for our newly elected and veterans to interact with one another.



# 2019 Legislative Session Includes Several County Issues

All eyes are on the State Capitol as we are in the midst of a very busy legislative session. Major changes to education have consumed the Senate, but they finally passed SB 451 yesterday and sent it to the House! It remains to be seen what will happen there. However, CCAWV is busy focusing on our legislative priorities and working to get those introduced on both the House and Senate side: the 1% Permissive Sales Tax Authority for Counties; Local Government Salary Bill Mechanism; Increasing the Roll-back Provision Maximum; SB 295 Protection for Court Security Officers; Expanding Authority for Disposal of County Property; and HB 2663 - Exempting Agriculture Buildings from County Building Code. HB 2663 passed out of House Agriculture and is now in House Gov Org. With elimination of the Business & Inventory Tax (HJR 17) still a focus for House and Senate leadership, and a resolution to increase homestead exemptions on property taxes (HJR18), counties must be vigilant in protecting our current limited revenue sources. There have been several bills introduced to cut severance tax revenues; oil & gas, coal, and limestone. We are working hard to keep the "county share" of severance revenues protected! Don't forget when we send out a Call to Action to notify your senators and delegates on bills that are of the utmost importance to counties.

## Director's Discussion with Vivian Parsons



Legislative session has commenced and started out with a bang! CCAWV has been proactive this year and worked on drafting legislation that we have presented to House Speaker Roger Hanshaw. We are also working closely with the Senate to get our priorities introduced.

Education appears to be the main focus currently, along with the elimination of the Business & Inventory Tax. Our Legislative Committee is holding weekly calls and the Legislative Lineup is being distributed every Wednesday. This document provides updates on any and all legislation that would have an impact on counties. CCAWV Lobbyist Steve Kominar is also at the Capitol and following our legislation. I encourage you to be involved and follow these bills—I am happy to answer any questions you may have. We have until March for session to end and things change quickly underneath the dome. Our team at CCAWV is working diligently to make sure counties are represented and our voices are heard!
