April is "National County Government Month" and the County Commissioners' Association of WV (CCAWV) will host their annual essay contest for eighth grade students across West Virginia. We encourage county commissioners to visit area schools and talk about the roles and responsibilities of commissioners. There are monetary awards for 1st (\$500), 2nd

(\$300), and 3rd (\$200) place student winners. There is also a monetary award (\$500) for the 1st place winner's Teacher to be used for classroom activities.

Students are asked to type a 500-word essay entitled How Does My County Commission Make Life Better For Me? A committee of commissioners and CCAWV Staff will serve as judges of the contest. CCAWV 2019 Legislative Synopsis

Our 2019 Legislative Session was definitely one to remember for many reasons and was similar to last year for our counties. We had another teacher strike, although this one was much shorter in duration and another attempt at reduction of the Business Inventory Tax. Although CCAWV worked diligently on establishing our legislative agenda and communicating this out to our legislators, education reform took precedence and consumed much of the 60-day session. On a positive note, we were able to hold several meetings with legislative leadership to continue discussions on county regional jail cost relief, had commitment for a CCAWV seat during the next year on a committee to look for solutions to this relief, and continued to education about the lack of county revenue resources to meet county responsibilities. We also worked in unison with the coal industry to protect county coal severance tax revenues, even though some reduction to the states severance share was passed by the legislature.

We are now in the process of identifying any and all legislation passed that would have an impact on counties so we can communicate those changes. With the hundreds of bills introduced each session it becomes a full time job tracking legislation and how it could impact counties. This is why CCAWV values its relationship with counties because your feedback and input are essential to understanding legislative changes.

In the next few weeks we will provide our final Legislative Lineup summarizing bills for the 2019 regular Legislative Session. This summary will include all bills that were passed during session affecting counties, the effective date and a description of the bill. A copy will be sent out on our ListServ, will be mailed to each member and will be posted on our website.
